**Günter Stummvoll (Dr.Phil.)** studied sociology at the *University of Vienna* and at *Monash University* in Melbourne, Australia and architecture at the *Technical University in Vienna*. For his graduation in sociology, he conducted research on “Neighbourhood Watch” in Melbourne and on “Community Policing” in Vienna. He has taken post-graduate training in social science at the *Institute for Advanced Studies (IHS) in Vienna (2000-2002)*. He was awarded an EU-Marie Skłodowska Curie Early-Stage Training at the *Department of Criminology, Keele University, England (2002-2003)*.

Günter Stummvoll started his international career in the social sciences as project assistant in the Department of Traffic Psychology at the *Austrian Road Safety Board (Kuratorium für Verkehrssicherheit KFV)* in 1998-2001. From 2005 to 2008 Günter Stummvoll worked as researcher at the *Institute for the Sociology of Law and Criminology (IRKS)* in Vienna. In 2008 he was awarded a 2-year EU-Marie Skłodowska Curie Fellowship for the study of ‘European norms and standards in design-led crime prevention’ based at the *Centre for Criminological Research at Keele University* in the United Kingdom. From Sept. 2010 to Jan. 2012 Günter Stummvoll earned a Marie Skłodowska Curie Re-Integration Grant and was employed at the Department for Building and Environment at *Danube-University Krems, Austria*, where he conducted research and taught urban sociology and criminology. From Dec. 2014 to Dec. 2016 Günter Stummvoll was a member of the scientific staff at the research institute *Mediacult* in Vienna, Austria, where he conducted research on “Filmfestivals in Vienna” and “Allotment Gardens in Vienna”.

From March 2017 to February 2022 Günter Stummvoll was employed at the *European Centre for Social Welfare Policy and Research* in Vienna, Austria, where he conducted research as a principal investigator at the interface of criminal justice, health promotion and social welfare policies (research projects: “Diversion: Therapy instead of Punishment”; “Social Work and Policing”; “Juvenile Gang Crime”).

Currently, Günter Stummvoll is employed at the Institute of Conflict Research (*Institut für Konfliktforschung*) in Vienna, where he coordinated the implementation of the [International Self-Report Delinquency Study](#) in Austria. At present, he works in projects on “prevention of burglary”, “probation services” and “hate crime”.

Günter Stummvoll has a long teaching record. Since 2011 he has been teaching seminars at the *Department of Sociology at Vienna University, Austria*: “Deviance and social control”, “sociology of trust”, “reading classics in sociology”, “introduction to sociology”, “theories of social action”, “hate crime”, “civil society and theories of democracy” and “research methodology”.
